**Neni 6**

Objekti i veprimtarise se shoqerise do te jete:

Konsulence ekonomike, financiare, menazheriale, shitjeje, konsulence per kredimarrje ne sistemin bankar shqiptar, hartim plan biznesi, studim tregu, konsulence marketingu dhe promovimi aktiviteti te subjekteve, konsulence ne burimet njerezore, sherbime perfaqesimi ndaj subjekteve edhe individeve, vendas apo te huaj, ndermjetesim financiar edhe trajnime etj, per bizneset edhe individet, si dhe cdo sherbim tjetër financiar dhe kontabel te lejuar nga legjislacioni shqiptar per kete lloj shoqerie qe ka lidhje me kete objekt veprimtarie.



**FOUNDING ACT OF LIMITED LIABILITY COMPANY  
UNIQUE SWIFT GENERAL TRADING L.L.C**

This day, on 07. 10. 2021 the following persons:

Mr.MOKHTAR JALALI, son of Sayed sheh (father's name), Karima (mother's name), born on 08.03.1977, born in Kabul and resident in UAE Sharjah Sharjah, Flat No306, Ittihad Plaza Building, A1 Taawan United Arab Emirates, holder of the passport number 02103208 issued by the Afghan authorities on 09.10.2018 and

Mrs.NADIA NOORISTANI JALALI, daughter of Abdul rahim (father's name), Alia (mother's name), born on 24.10.1978, born in Nooristan and resident in UAE Sharjah Sharjah, Flat No306, Ittihad Plaza Building, A1 Taawan, United Arab Emirates, holder of the passport number P01757986, issued by the Afghan authorities on 06.10.2019,

upon free will, establishes the limited liability company "UNIQUE SWIFT GENERAL TRADING L.L.C" and drafts for that purpose the company Founding Act with the following content:

**Article 1**

The limited liability company named "UNIQUE SWIFT GENERAL TRADING L.L.C" is hereby founded.

**Article 2**

The company is declared established under the full observance of the norms contained in this act.

**Article 3**

The activity of the company, its relations with third legal and natural persons, local and foreign, state and private ones, are regulated by virtue of Law No. 9901 dated 14.04.2008, as well as other legal acts and by-laws issued for the implementation of this law. The company shall be responsible only for its assets.

**Article 4**

The company headquarters will be in Tirana, Rruga" Riza Cerova", Pallati Belader, Ap. Nr 7. Tirana.

**Article 5**

The activity of the company, its name and headquarters defined in this Founding Act cannot change without the consent of its founder.

**Article 6**



The scope of company activity will be:

Economic, financial, management consulting, sales, credit consulting in the Albanian banking system, business plan drafting, market research, marketing consulting and promotion of entities' activities, human resources consulting, representation services to entities and individuals, local or foreign ones, financial mediation and training, etc, for businesses and individuals, as well as any other financial and accounting services allowed by the Albanian legislation for this type of company that is related to this scope of activity.

Import, export, wholesale and retail trade, trade of industrial goods, food, fruits and vegetables, various alcoholic and refreshment drinks, clothing, construction materials, spare parts for vehicles, machinery, hydro-sanitary equipment, furniture, processed and unprocessed cosmetics, medicinal plants, timber, plastic and duralumin and any kind of goods allowed by the Albanian legislation for this type of company.

Activities in the field of real estate agency, sale-purchase of movable and immovable properties and any related activities.

Activities in the field of civil and industrial constructions of all kinds.

For the performance of the activity of the above company in respect of which the relevant permit is needed, the company shall be obliged to obtain in advance this permit from the competent bodies.

#### **Article 7**

The initial company charter capital is 100.000 ALL. The company capital is divided into 1 (one) quota, the number of parts 2 (two), owned by the partners who founded this company, Mr. MOKHTAR JALALI with 50% of shares, Mrs. NADIA NOORISTANI JALALI with 50% of shares.

#### **Article 8**

For the needs of work and exercise of their activity, the company can open an account at any bank recognized by law, whether private or state one.

#### **Article 9**

The duration of company's activity shall be for a period of over 10 years and shall start from the moment of its registration with the National Business Center, unless it ends according to the provisions of law or by decision of the Assembly of Partners.

Further, the company can be dissolved at any time for the cases provided by law.

#### **Article 10**

The company consists of two partners MOKHTAR JALALI and NADIA NOORISTANI JALALI

The company administrator is the sole partner, MOKHTAR JALALI, who is elected for a term of 5 years, with the right of re-election.

#### **Article 11**



The bodies are responsible for maintaining the character of secrecy of the activity and company documentation.

#### **Article 12**

The company bodies are:

- 1- Partners' Assembly decision
- 2-Company Administrator, MOKHTAR JALALI
- 3-Commission of Chartered Accountants

The modalities of their establishment and functioning are defined in the Statute attached.

#### **Article 13**

For work needs, this company may also hire various specialist employees, with regular employment contracts, according to the legal provisions in force.

#### **Article 14**

More detailed provisions for the company are defined in the Statute attached.

#### **Article 15**

This Incorporation Act was edited in 4 copies.

The Administrator Mokhtar Jalali will act on behalf of the company in formation until its registration at the National Registration Center.
