**ARTICLE 1  
ESTABLISHMENT AND NAME**

- 1.1. This day of 2021-10-11 the limited liability company **H & M Hennes & Mauritz Albania SH.P.K.**, (hereinafter referred to as the “**Company**”) is incorporated under Albanian Law no. 9901, dated 14.04.2008 “*On Entrepreneurs and Commercial Companies*”, as amended.
- 1.2. The Company acquires legal personality after its registration with the commercial register maintained by the National Business Centre in Tirana, Albania.

**ARTICLE 2  
REGISTERED OFFICE**

- 2.1. The registered office of the Company is at the address: Str. Ibrahim Rugova, Nd.40, H.2, Ap.3, 1019 Njesia Bashkiake Nr. 5, Tirana, Albania.
- 2.2. The Company may open and maintain offices and/or transact business at other locations within the territory of the Republic of Albania, upon decision of the Administrator(s) of the Company.

**ARTICLE 3  
PURPOSE OF ACTIVITY**

- 3.1. The purpose of the Company shall be to transact any and all lawful business and/or to engage in any lawful act or activity for which a limited liability company may be organized under the laws of Albania, as they may be amended from time to time.

**NENI 3  
OBJEKTI I VEPRIMTARISE**

- 3.1. Qellimi i Shoqerise eshte zhvillimi i çdo aktiviteti biznesi dhe/ose aktiviteti te ligjshem qe mund te ushtrohet nga një shoqeri me pergjegjesi te kufizuar sipas ligjeve te Shqiperise, siç mund te ndryshohen here pas here.

3.2. In particular, the object of the company includes the operation of retail stores, both physical and online, for garments (women, men, kids etc.), accessories, bags, shoes, jewellery, cosmetics, homeware, kitchenware, furniture, interior, food and beverages etc. The company may perform all accessory activities which are needed for the above object, including, import and export.

3.2. #### **ARTICLE 4 DURATION**

The duration of the Company's activity shall be unlimited.

#### **ARTICLE 5 SHARE CAPITAL**

The initial share capital of the Company is ALL 100, consisting of one (1) share with a value of ALL 100.

#### **ARTICLE 6 SOLE SHAREHOLDER**

The Sole Shareholder of the Company is H & M Hennes & Mauritz GBC AB, a company, established and existing under the laws of Sweden, registered with the Commercial Register of Sweden, with registration number 556070-1715.

#### **ARTICLE 7 MANAGEMENT OF THE COMPANY**

7.1. The properties, business and affairs of the Company shall be managed and performed by up to two Administrators which are authorized to act severally, unless otherwise indicated by the resolution of the Sole Shareholder.

### **AUDITOR**

## ARTICLE 9

- 9.1. The fiscal year of the Company shall be from January 1<sup>st</sup> to December 31<sup>st</sup>.
  - 9.2. By exception, the first financial year begins upon the Company's incorporation and ends on the 31<sup>st</sup> of December of the same year.

ARTICLE 10  
WINDING UP

- 10.1. The winding up and the appointment of the liquidator/s shall comply with the law no. 9901, dated 14.04.2008 "*On Entrepreneurs and Commercial Companies*", as amended, and any other applicable law.

*The present Articles of Association are drawn up and signed by the shareholder, in 3 (three) copies in Albanian and in English languages, each having the same value. In case of discrepancies between the Albanian and English version, the later version shall prevail.*
