Kreu I

OBJEKTI, EMERTIMI, SELIA, REGJIMI JURIDIK

Neni 1

Objekti i shoqerise

Shoqeria “**HYUNGLOBAL ALBANIA**” SH.P.K., ka si objekt veprimtarie:

1. Tregeti me pakice te Autoveturave, Mjeteve Motorike te përdorura dhe te reja
2. Import eksport ne Industrine e Automobilave dhe te tregetimit te gjitha llojeve te produkteve.
3. Shitblerje e pasurive te luajtshme apo te paluajtshme, mjeteve te transportit, makinerive, automjeteve t'i marre ose t'i leshoje me qera, te marre pjese ne tenderin e tyre, si dhe te beje ndertime, rikonstruktive, rregullime, sherbime, etj., apo te transferoje te palet e tjera punet e tyre, me pakice dhe shumice.
4. Tregtim me pakice dhe shumice, ne format e parashikuara dhe te lejuara nga legjislationi shqiptar.
5. Shoqeria, mund te kryeje per permbushjen e qellimeve te saj cdo lloj operacioni tregtar, mund te vendose pasuri te luajtshme dhe te paluajtshme, t'a hipotekoje katra pasuri na marrinistrin e pasurive te paluajtshme ne emri te cai

6. Perfitoje, transferoje, te marre apo jape me qera, te bleje dhe shese, si dhe te kontraktoje, te drejten e markes, patentes, licences, dhe te drejtat e tjera qe jane te ngjashme me keto.
7. Shoqeria, sic mund te ushtroje punet qe tregohen ne objektin e veprimtarise se saj, brenda dhe jashte vendit, ashtu edhe mund te marre pjese, te perfitoje apo te transferoje nga/te palet e tjera, mund te marre pjese ne kapitalet e personave juridike dhe fizike, te vendit apo te huaj, te krijuar ose qe krijojen me qellim tregtie, industrie, etj., ne lidhje me keto fusha.

Neni 2

Emertimi dhe Selia Juridike e Shoqerise

2. Selia juridike e Shoqerise ndodhet ne adresen: Njesia Bashkiake Nr.13, Rruga "Selite e Vjetër", Ndertesa Private Nr 7, Hyrja Nr 1, Ap Nr 6 Tirane / Shqiperi.
3. Shoqeria mund te krijoje qendra sekondare, dege, zyra perfaqesimi ne qytete te tjera te Shqiperise ose jashte vendit.

Neni 3

Forma Juridike

1. Shoqeria eshte shoqeri me perjegjesi te kufizuar. Veprimtaria e saj i nenshtrohet dispozitave te Aktit te Themelimit, Statutit dhe legjislacionit shqiptar ne fuqi
2. Me vendim te ortakut mund te ndryshoje formen juridike te Shoqerise, ne qofte se ne te ardhmen krijojen premisa me te favorshme per funksionimin e saj sipas legjislacionit shqiptar. Ne kete rast Ortaku do te pershtase Aktin e Themelimit dhe Statutin e shoqerise, si dhe do te bejne regjistrimin e saj ne rregjistrin tregtar, ne organet kompetente shqiptare.
3. Shoqeria gezon personalitet juridik nga data e regjistrimit te saj ne regjistrin tregtar nga organet kompetente dhe ne perputhje me ligjin.
4. Shoqeria do te kete vulen e saj.

Neni 4

**MEMORANDUM OF ASSOCIATION
OF THE
LIMITED LIABILITY COMPANY

The founder who signed below as follows:

1. **Mr. TAEHYUN KIM**, Korean citizen, date of birth 25.04.1974, son of Kim Jong Gi, born in Dalbit 1-ro, Sejong-si / Republic of Korea and resident in the Republic of Korea, holder of Republic of Korea passport No. M76198502, adult and with full legal capacity to act.

hereinafter referred to as the Shareholder of the Company "HYUNGLOBAL ALBANIA" SH.P.K

This 24th day of April 2024, who, upon his own free will and pursuant to Law No. 9901 dated 14.04.2008 " On Entrepreneurs and Companies", he decided to incorporated the Limited Liability Company, based on the following conditions:

Chapter I

THE OBJECT OF ACTIVITY, NAME, HEADQUARTERS, LEGAL STATUS

Article 1

The object of the activity

The object of the company "HYUNGLOBAL ALBANIA" SH.P.K activity, is as following:

1. Retail trade of used and new cars, motor vehicles
2. Import-export in the Automotive Industry and trade of all types of products.
3. Sale and purchase of movable or immovable assets, means of transport, machines, renting or leasing vehicles, taking charge of their auction, as well as to perform constructions, refurbishments, repairing, services, etc., or to subcontract their work to other parties, in small or large quantities.
4. Retail and wholesale trade, in accordance with the methods provided for and allowed by legislation.



5. The company, in order to fulfil its aims, is allowed to perform any trade operation, dispose of real estate, to mortgage the real estate on its behalf at the real estate register.
6. Acquire, transfer, rent or lease, buy and sell, as well as contract, trademark, patent right, license, and other similar rights.
7. The company, as it can carry out the tasks indicated in the object of its activity, inside and outside the country, it can also participate, benefit or transfer from/to other parties, can participate in the capitals of national or foreign natural persons /legal entities established or to be established for the purpose of trade, industry, etc., in relation to these sectors.

Article 2

Name and Legal Headquarters of the Company

1. The shareholder of the company decided to name it "**HYUNGLOBAL ALBANIA**" sh.p.k.
2. The legal headquarters of the Company is located at the address Njesia Bashkiake Nr.13, Rruga "Selite e Vjeter", Ndertesa Private Nr 7, Hyrja Nr 1, Ap Nr 6, Tirana / Albania.
3. The company can establish secondary centers, branches, representative offices in other cities of Albania or abroad.

Article 3

Legal status

1. The company is a limited liability company. Its activity is subject to the provisions of the memorandum of association, statute and the Albanian legislation in force
2. On its decision, the shareholder, may change the legal status of the Company, if more favourable premises for its functioning are created in the future in accordance with the Albanian legislation. In this case, the shareholder shall adapt the Memorandum of Association and the Articles of Association of the company, as well as it shall perform its registration in the commercial register, in the competent Albanian bodies.
3. The company enjoys legal personality from the date of its registration in the commercial register by the competent bodies and in accordance with the law.
4. The company shall have its own seal.

Chapter II

THE RIGHTS AND OBLIGATIONS, DURATION



Article 4

The rights of the Company and the shareholders

1. The company has the right to conclude agreements and sign contracts in the territory of Albania and outside of it.
2. The company has the right to incur material and intellectual wealth.
3. The company has the right to participate as a shareholder in one or several companies in Albania or abroad, in accordance with the Albanian legislation.
4. The company responds to third parties only and exclusively with its paid in the company and the with its assets.
5. The shareholder participates in the administration of the company's activity in accordance with the Memorandum of Association and the Articles of Association, himself or through his representatives.
6. The shareholder has the right to receive all the information related to the company's production, design, implementation and commercial activities, such as balance sheets, economic accounts, etc.

Article 5

Duration

The duration of the company is indefinite.

Chapter III THE SHARE CAPITAL

Article 6

The share capital

The shall capital of the company is **100,000 (one hundred thousand) ALL.**

It is divided into **1 (one)** share (quota) worth **100,000 (one hundred thousand) ALL.**

The sole shareholder of the company is:

- 1) Mr. TAEHYUN KIM, owner of 1 (one) share worth 100,000 (one hundred thousand) ALL, which is 100% of the company's share capital.**

Chapter IV LEGAL PERSONALITY

Article 7



The company obtains its legal personality on the day of its registration in the Commercial Register at the National Business Center in Tirana, as well as it commences its activity by obtaining the license for the operating the activity.

CHAPTER V ADMINISTRATION

Article 8

1. The company shall be administered by **Mr. Arian Seiti** with ID no. H41202077T, who shall represent the company in relations with third parties and shall exercise his duties and powers for a period of **5 (five)** years and with the right of re-election from 24.04.2024 to 23.04.2029 and re-election.
2. The administrator may delegate his powers in writing in the form of authorization or power of attorney.

Chapter VI OTHER PROVISIONS

Article 9

1. The profits made by the Company, after the liquidating of legal obligations, shall remain to its shareholder.
2. This Memorandum of Association is drafted and signed in 3 (three) copies, all with the same legal value.
3. One copy is filed in the initial documentation of the company.
