The incorporation act by the sole partner is also considered a decision by the partners for the creation of the limited liability company. #### Company Capital Article 5



The administrator is the representative of the company in relations with third parties and has full authority to manage the company. Every contract will be executed by him and, in his absence, by a representative with a special power of attorney.</p> <p><b>Net Income</b></p> <p><b>Article 7</b></p> <p>The net income of the company belongs to the partners of the company.</p> <p><b>Rights of Founding Partners</b></p> <p><b>Article 8</b></p> <p>The founding partners have the right to appoint other administrators for material assets.
