SALE CONTRACT OF QUOTAS OF THE COMPANY "Growchem Chemistry Fertilizer" L.L.C

Today on date ___/12/2019, before me Notary of Tirana Notary Chamber, Maria DANO, with office located on the street "Kont Urani", Nr.39, the buying party and the selling party of this contract were personally presented.

The subjects of this contract upon their free will and wish requested me the notary to edit the contract of sale of the basic capital quota in the company "**Growchem Chemistry Fertilizer**" L.L.C. as follows :

**ARTICLE 1
SELLING PARTY**

MRS. MERCEDES ULQINAKU, Albanian citizen, daughter of Myrteza, born in Tirana, on 12/05/1982 and resident in Fier, Str. "Vëllezërit Semanjaku", Region 1, major with full legal capacity to act, unknown to me the notary, for whose identity I was assured by the personal ID submitted to me with No. **I25512076I/032615344**;

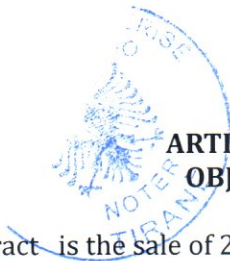

**ARTICLE 2
BUYING PARTY**

MR. KÜRŞAT KAYHAN, Turkish citizen, son of Ali Yasar, born in Kars, Turkey, on 23/02/1988 and resident in Turkey, currently resident in Tirana, major with full legal capacity to act, unknown to me notary, whose identity I verified based on the passport of the Turkish state he submitted to me with No. **U14352023**.

**ARTICLE 3
LEGAL BASIS**

1. This contract is drafted pursuant to and on execution of the free and complete will of the parties as set forth in Article 1 and Article 2 as above.
2. This contract is also drafted pursuant to and on execution of :
 - a) The Civil Code of the Republic of Albania and in particular Article 659, Article 690 and Article 705 thereof;
 - b) The statute of the company "**Growchem Chemistry Fertilizer**" L.L.C;
 - c) Law no. 9901, dated 14.04.2008 "On traders and commercial companies" and in particular Article 73 and following;
 - d) Law no. 110, dated 20/12/2018 "On notary";
 - e) Decision of the Assembly of Partners of the Company "**Growchem Chemistry Fertilizer**" L.L.C, with No. 1, date 17/12/2019.



ARTICLE 4 OBJECT

1. The object of this contract is the sale of 2 quotas respectively:
 - Sale of a quota comprising 33.00% (thirty-three percent) of the value of the basic capital held by the selling party **MRS. MERCEDES ULQINAKU**, in the capital of company "**Growchem Chemistry Fertilizer**" L.L.C, being the property of the selling party and all related rights;
 - Purchase of a quota comprising 33.00% (thirty-three percent) of the value of the basic capital held by the selling party **MRS. DORIANA DINE**, in the capital of company "**Growchem Chemistry Fertilizer**" L.L.C, being the property of the selling party and all related rights;
2. Buying party **MR. KÛRŞAT KAYHAN**, buys from the selling party **MRS. MERCEDES ULQINAKU** 33.00% (thirty-three percent) of the capital owned by the company "**Growchem Chemistry Fertilizer**" L.L.C. and the selling party **MRS. DORIANA DINE**, 33.00% (thirty-three percent) of the capital owned by the company "**Growchem Chemistry Fertilizer**" L.L.C.

ARTICLE 5 PRICE

1. The selling price of the quota and as set forth in Article 4 of this contract is in the total amount of 66 000 (sixty-six thousand) ALL, which represents the value of the equity of the company.
2. The liquidation of the price set forth in point 1 of this article, from the purchasing party to the selling party, has been effected outside this notary office, the selling party is liquidated on the basis of the value in percentage of the quota they own and has no objection or disagreement to this fact at the time of the editing and signing of this contract.

ARTICLE 6 OBLIGATIONS OF THE PARTIES

1. The obligations of the selling party:

- a) The selling party undertakes and declares that it is the owner of **33.00%**, **each in** the basic capital of the company "**Growchem Chemistry Fertilizer**" L.L.C, and sell these quotes at a general price of 66 000 (sixty-six thousand) ALL, payment which we have received outside this notary office, as set forth in Article 5 of this contract.
- b) Guarantee the buying party that these quotas are free from any liens and liabilities to third parties and to any claims that may be raised by third parties for infringing the buying party's ownership right (eviksjon) the selling party is ready and obliged to appear immediately at the request of the buying party and any other third party claiming such quota, before all judicial and administrative authorities to defend its right as the legal owner of such quotas after the signing of this contract.

2. Obligations of the purchasing party:

- a) The purchasing party has taken over the quotas and has liquidated the selling party on the price set forth in Article 5 of this contract, having no objections according the legal document.



3. Mutual obligations:

- a. The contracting parties state that all the obligations described above and all that derive from this contract of sale have been fulfilled by them and they have no mutual obligation between them.
- b. The contracting parties state that the quotas have been accepted by the buying party in the existing situation and they have no claim in regarding this action..

**ARTICLE 7
TRANSITIONAL CONSEQUENCES OF QUOTA TRANSFER**

- 1. The selling party as well as the buying party are mutually liable to the company for the obligations arising from the possession of quota subject to this contract..
- 2. The mutual liability of the selling party and the buying party to the company for the obligations arising from the quotas subject to this contract starts from the moment the quotas are passed upon the signing of this contract and terminates with the registration of this transfer in accordance with the provisions of law No. **9723, date 03.05.2007 "On the National Business Center "as amended.**

**ARTICLE 8
THE EFFECTS OF THE CONTRACT**

- 1. The transfer of ownership of quotas from the selling party to the buying party in accordance with the provisions of this contract terminates with the registration of this contract at the National Registration Center and in accordance with the provisions of law No. **9723, date 03.05.2007 " On National Bussiness Center " as amended.**
- 2. The transfer of quotas pursuant to this contract is registered in compliance with provisions of law **No. 9723, date 03.05.2007 "On the National Business Center "as amended**
- 3. The registration specified in paragraph 2 of this Article shall have a declaratory effect.

**ARTICLE 9
NOTARY EXPENSES**

- 1. The notary expenses of the contract shall be borne by the parties in equal proportion.

**ARTICLE 10
ATTACHED DOCUMENTS**

**ARTICLE 11
FINAL PROVISIONS**

- 1. Thus, upon the signing of this contract by the contracting parties and its signing by the notary, the ownership of basic capital is removed from the selling party and the owner of

quotas becomes **MR. KÜRŞAT KAYHAN**, enjoying all legal rights to these quota in company, "Growchem Chemistry Fertilizer" L.L.C.

2. **MR. KÜRŞAT KAYHAN**, becomes the sole partner of company "KÜRŞAT KAYHAN" L.L.C. with 100% (one hundred percent) of the capital of the company.
3. The parties declare that they have become aware of the registration of this notary act in the NBC Tirana according to the requirements of the legislation in force.
4. The contract on the parties' request was drawn up in four copies, in three pages, pursuant to Law no. 110, dated 20/12/2018 "On Notary", of which one is preserve in this office and the other three are given to the parties.
5. 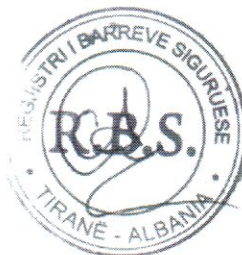
